Chair's Report



Welcome to Bankstown Canterbury Community Transport's (BCCT) 2023 Annual Report, and my fifth Chair's Report. As you would expect, throughout the past year we have continued to pursue our vision, i.e.:

To eliminate social isolation by ensuring individuals have safe, caring, and accessible transport services, that allow them to retain their independence and connections to the community.

Some might think that the myriad of communication channels available to us all must surely be reducing social isolation, but recently announced research clearly and emphatically shows that loneliness is prevalent and increasing across the country in all age groups. I wasn't overly surprised by the results of this research, but it did confirm and reinforce the need to continue the pursuit of BCCT's vision.

The past year or so has presented many changes, challenges and opportunities to all organisations involved in the aged and disability care sector, including community transport providers. To name a few, there's been changes in Government at both Federal and State levels, the downgrading of the COVID-19 pandemic and its associated restrictions, a Disability Royal Commission, Aged Care reforms, including proposed new funding structures, and shortly there will be a new Aged Care Act.

The changes in governments, and their recent focus on budgetary pressures and priorities has created some uncertainty around ongoing funding for community transport, and even the information technology (IT) infrastructure and systems we depend on to manage the transport services we provide - Reduced government funding and rising costs for community transport are looking likely in the coming year. You can support us, yourself, and your fellow community transport users by lobbying your local members of parliament to at least maintain current funding levels, if not increase them.

Regarding the COVID-19 pandemic, the world-wide change in response to it and how we all manage its still ongoing risks continues to present challenges to services like ours. As per our vision, we will continue to keep client, staff and volunteer safety in mind when planning and delivering caring and accessible transport services. In line with the reduced pandemic restrictions, we have returned to delivering all our usual transport options, such as travel to and from medical appointments and retail centres.

We also have a wide variety of social outings on offer throughout the year - So if you want to get out of the house and travel about with old and/or new friends, please consider booking a social outing.

Over the past year the Federal Department of Health and Aged Care has been communicating and consulting with all organisations in the aged care sector, including community transport providers, about the current and pending reforms, including the new Aged Care Quality Standards and the new Aged Care Act.

The overriding, and admirable, aim of these reforms is "improving quality of life". These reforms will create some changes in how we manage and deliver our services, and how we communicate and consult with our clients - Stay tuned for more information on these reforms and changes throughout the coming year.

I'd like to give a big thank you to my fellow volunteer directors (Ron Norman, Carolyn Lamour, Tony Francis, Ann Garland, Dennis McCroary, and Brett Bartholomew, who joined our board in late 2022), our ex-CEO Rachel Thompson and ex-Operations Manager/New CEO Gary Williams, and all of our much appreciated leadership team, staff and volunteers, for the effort and commitment you all put into ensuring our valued clients are provided with a broad and varied range of transport services.

... And lastly, a heartfelt thank you to all our clients for using our services.

Her legacy being that she has left the organisation in a strong financial position to face the new funding regime which will soon be upon us in 2025. We wish Rachel all the best in her personal and career endeavours.

Life returned to more normality this past 12 months as we waved goodbye to the pandemic. The office undertook some further changes with an influx of youth manning the client services. Whilst they are still learning the nuances of the booking system and dealing in the aged care sector, their enthusiasm is infectious. However, we also saw the retirement of Deidre Dunn, Dee to all those whose lives she touched. Her experience and empathy after 10 years are irreplaceable and whilst we wish her well in her retirement, don't be surprised some time down the track to hear voice as she is keen on doing some volunteer work in the future.

The Aged Care reforms were again pushed back another 12 months and will be implemented from 1 July 2025. Considering it has constantly been pushed back in the 6 years I have been here; this may not be the last deferment but this time the Federal government is proceeding with a new Aged Care Act, so this might be the final hurdle. The proposed Support at Home scheme will look very different once implemented so hang on for the ride.

Whist I've only be in this role for a few weeks, I'd like to acknowledge the support of our Board and look forward to the challenges ahead

Operations Manager's Report

Another year has managed to fly by but thankfully without a pandemic and life returns to normal. We've made a few changes in the past year, not least being the publication of a newsletter, which offers some information for the aged care community and gives an insight into BCCT. It also incorporates our social outing program.

We've also re-built our bus hire services and now have regular Council bookings as well as several community groups including Campsie Probus, Bankstown Legacy, Greek Community Group, Coolaburoo, East Hills Baptist Group, Georges River Seniors Group and Donington Gardens Retirement Social group as regular users of this service. A benefit from these group hires is that we meet new prospective clients who are exposed to the full range of services we offer. With the impending changes in funding from the Federal government, it is imperative we continue to grow our client base to ensure our longer-term viability.

These initiatives are also part of our broader 2021-24 Strategy Plan.

Statistics

- We completed 59,237 trips in 2022-23, up from 37,296 last year. This was a massive increase of 59% on year and back to pre-Covid levels,
- Trips by funding source were distributed between CHSP 83.4%, CTP 5%, NDIS 5%, Home Care Packages 6% and Health Related 0.6%,
- New clients assessed 1,715. Female 61% and Male 39%, minimal change in ratio
- Home Care Packages grew exponentially by 258% from 134 to 347, which is part of the push to move people away from CHSP subsidised services. Whilst only 101 new clients were on a package, 246 existing clients transitioned over.

With staff leaving, we have staff replacements. Mariam and Vicki have joined us in the back end of the office looking after administration, Mahendra and Kim as new drivers and Aaron, Sandy and Daniel in the engine room that is the booking staff.

Fatat and Hanh continue to plough through the seemingly endless referrals to onboard new clients as well as backing up the booking staff.

Well done to all our drivers without singling anyone out. Anyone can drive a vehicle but it's your empathy, understanding and willingness to go the extra yard that makes you such a valuable asset.

Josie moved from being a driver to being on the client services team to their Team Leader.

The ever-bubbly Hayley continued her good work developing our newsletter and our social outing programs. Look out in 2023-24 for a couple of new initiatives she's developing.

Alan, our rock, your rock. His efforts to make the day run smoothly and meet the constantly changing demands of our clients is nothing short of outstanding.

Finally, a massive thank you to our volunteers. We now have Lesley driving several days per week, Cisco popping in when he can do clean vehicles, Gaye and Les who work the assisted shopping, Kathy who helps the booking and admin team a couple of days per week, and Vin and Jan who you see regularly assisting on outings. It takes a special person to work as a volunteer and we are lucky and grateful to have you on board with BCCT.

Fleet & Services

Our vehicle fleet continues to be upgraded after the Covid hiatus and we took delivery of a further five Toyota HiAce Commuter vans. The current fleet structure is being reviewed to improve our mix and serviceability to our clients. We will move to less large buses and fewer cars whilst increasing our van fleet.


Treasurer's Report

I am pleased to present the Annual Treasurer's Report for Bankstown Canterbury Community Transport Co-operative Limited (BCCT) for the fiscal year ending 30 June 2023. Like many organisations impacted by the effects of COVID-19, this financial year remained dedicated to restoring service delivery outputs while maintaining prudent expense management due to economic conditions. BCCT recorded an operating deficit of \$347k (FY22: surplus of \$402k).

Funding & Other Grant income saw an 11% decrease compared to last year, as some of the funding was either one-off or not renewed. However, Passenger income saw a significant recovery, similar to pre-COVID levels, with a 60% increase compared to last year. Other Income also declined due to the cessation of Government stimulus funding.

Expenses as a whole increased 13% when compared to the previous year. This increase can be attributed to:

- the recovery of service delivery (an increase in trips increases service delivery costs),
- augmented employee expenses stemming from wage hikes; and
- elevated motor vehicle and operational expenditures due to the increased volume of trips and inflationary pressures.



BCCT's cash reserves decreased, sitting at \$3.36M (2022: \$3.86M).

Operating result

The main sources of funding for FY23 remained government contracts.

After Balance Day Events

On the 28 June 2023, the members voted to change organisation structure from a Co-operative to a Company Limited by Guarantee. In July 2023, the Co-operative has received permission from Fair Trading NSW to make this change. At the date of signing the annual report, the Co-operative has applied to Australia Securities and Investments Commissions (ASIC) for the change and is awaiting approval of the application.

Significant Changes in the State of Affairs

In the opinion of the Directors there were no significant changes in the state of affairs of the Co-operative that occurred during the financial year under review not otherwise disclosed in the financial statements.

Dividends

The Co-operative is a not-for-profit organisation and does not pay dividends.

No person has applied for leave of Court to bring proceedings on behalf of the Co-operative or intervene in any proceedings to which the Co-operative is a party for the purpose of taking responsibility on behalf of the Co-operative for all or any part of those proceedings. Opinion

I have audited the financial report of Bankstown Canterbury Community Transport Co-operative Limited ("the Entity") which comprises the statement of financial position as at 30 June 2023, the statement of profit or loss and other comprehensive income, the statement of changes in equity and the statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies, and the declaration by the Board of Directors.
