# Chair's Report



Welcome to the Bankstown Canterbury Community Transport (BCCT) 2024 Annual Report, and my sixth Chair's Report (Not something I thought I'd be saying when I joined the Board "for a while" almost 7 years ago!).

The past year has seen many changes for our organisation, and the Community Transport sector more broadly, with many more expected in the coming years.

Per the outcome of votes at a Special General Meeting in June 2023, BCCT has changed our legal structure from a Co-operative to Company Limited by Guarantee. This was done for various reasons, including reducing the amount and complexity of administrative, compliance and reporting obligations, and broadening the scope of grants that BCCT would be eligible for.

We have also made some changes to the structure of the operational and management teams under the leadership of our ex-Operations Manager / new CEO Gary Williams and will continue to do so as BCCT evolves in response to changes in the operating and regulatory environments.

During the year the Board farewelled our Deputy Chair Carolyn Lamour – We thank Carolyn for her many years of service to BCCT and wish her well for the future. Tony Francis has taken on the Deputy Chair role, and we are currently seeking new directors to join our voluntary Board – You can find out about volunteering for a variety of roles at BCCT here: <a href="https://bcct.org.au/volunteering/">https://bcct.org.au/volunteering/</a>.

Like all Community Transport organisations, BCCT has been closely monitoring recent, pending, and proposed reforms to the aged care and disability sectors. BCCT has also been actively participating in efforts to influence reforms, contributing to research and lobbying efforts by the Australian Community Transport Association (ACTA) and the Community Transport Association (CTO). The challenges we face are many and are still developing - We will continue to engage with the change process to ensure we have a say in supporting the sustainability of our organisation and the Community Transport sector.

With 40 years' experience behind us, and despite the current uncertainties, we believe we have the resilience to continue to adapt and respond to the challenges and opportunities the future presents – The BCCT Strategic Plan 2024-2027 is nearing completion and will be launched soon.

While we have been considering the future, we have not lost sight of our vision...

To eliminate social isolation by ensuring individuals have safe, caring, and accessible transport services, that allow them to retain their independence and connections to the community.

... and we continue to deliver on our core business, a Community Transport service that is highly valued by our clients, which can be seen in the responses to our recent customer survey, e.g., 95.1% of BCCT customers rate our service levels as good or excellent.

# CEOs Report



The past twelve months has flown by, and I can't believe I've been in this role for that long. It has been a year of change, and only the tip of the iceberg. The new Aged Care Act that resulted from the Royal Commission was put out for consultation and eventually passed into law in October 2024. Whilst the overhaul was necessary in the face of the findings of the Royal Commission into residential care, some of the new governance and compliance requirements that now extend across the breadth of the aged care sector which will make for many onerous and costly demands on the organisation. These new demands will need to be tackled, and new systems put in place from 1 July 2025.

In addition, we also have the new Support at Home program being implemented, again on 1 July 2025, which looks to streamline the onboarding and harmonisation of the aged care support scheme. The aim is admirable, but the implementation will likely have many teething problems resulting in some care requirements not being met in the near term. The eventual aim is for the CHSP scheme to also be merged into Support at Home, with the onus of the program to move to a user pays model meaning organisations will need to move from a care/client focus to a commercial focus in order to survive. Fortunately, 2027 is the earliest it will transition but our organisation will then be pitted against taxis and Uber who do not need to comply with the Aged Care Act, thus giving them a commercial advantage. Very much a 'watch this space' scenario.

As part of this reform, we were invited to participate in the ACTA (national peak body for community transport) Transport Pricing Pilot. The aim of the scheme is to try to measure the added benefits that community transport provides. Funding is currently determined solely on the number of completed trips and does not recognise that we are often counsellors, companions and carers to some of our clients. It is the extra unpaid service that separates community transport from the commercial operators. Does your taxi driver come and knock on the door to check on your well-being when you are not waiting to be picked up or wait when you're not quite ready? What about having a chat to the staff about your day when you call up to make a booking. This pilot will attempt to capture some of these 'extras' that as an organisation and employee we just consider a part of our job, as well as the additional time used assisting clients with their mobility issues.

The organisation is also embarking on the re-accreditation process with the NDIA to become a registered NDIS provider once more. We allowed this to lapse during COVID but are well advanced along the registration process with bureaucracy the final hurdle. There was a new Act implemented on 3 October 2024 to weed out the unscrupulous providers that had entered the market and was well overdue. Hopefully, more funds will now be available for those who need it and spent with reputable well-meaning organisations such ours.

We also changed our business structure early 2024 from a co-operative to a private company. This enables more options for grants and investments and a more streamlined business operation.

We have had a few staff changes in 2024, with several long-term employees, notably Hayley and Simon, finding greener pastures either with a new employer or retirement, but the addition of Regan and Sandy in the office, and Enza and Denis as drivers. Our volunteer base grew with the addition of Laurie and the return of Kathy. Many thanks for the Board support during the year, my able lieutenants Josie, Alan and Marijana, and all the staff that help deliver our service and make my job so much easier.

I am pleased to present the Annual Treasurer's Report for Bankstown Canterbury Community Transport Co-operative Limited (BCCT) for the fiscal year ending 30 June 2024.

This financial year has been devoted to enhancing service delivery outputs while exercising prudent expense management in response to prevailing economic conditions, including higher costs of living.

BCCT recorded an operating deficit of \$437k (FY23: operating deficit of \$347k).

#### Revenue and Other Income

Funding Income & Other Grant Funding saw a 6% increase compared to last year, partly attributed to CPI increases.

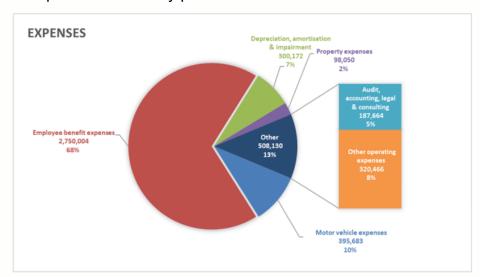
Income from Passengers & Outings saw a 24% increase compared to last year, due to more trips delivered.

Other Income remains on par with last year.

#### **Expenses**

Total expenses increased by 9% compared to last year.

This can be attributed to: increases in service delivery cost (as a result of increased trips), higher employment costs stemming from Fair Work wage rises, and increases in other operational expenditures due to the increased volume of trips and inflationary pressures.



#### Cash

Cash reserves have decreased compared to last year, sitting at \$2.87M (2023: \$3.36M).

#### **Principal Activities**

The principal activities of the Company during the financial year were to provide transport assistance to the Commonwealth Home Support Programme (CHSP) and other disadvantaged groups in the community.

#### **Significant Changes**

On the 11th January 2024, Bankstown Canterbury Community Transport Co-Operative Limited changed its corporate structure and became a registered company under the Corporations Act 2001. The Company is now known as "Bankstown Canterbury Community Transport Limited" and is a public company limited by guarantee. As part of this change the membership was reduced from 81 members to only the 6 members represented on the board.
